Congressman Carson Introduces the Medical Research for Our Troops Act

WASHINGTON, DC—On June 11, Congressman Andre Carson (IN-07) and Congressman Mike Levin (CA-49) introduced <u>H.R. 3906</u>, the Medical Research for Our Troops Act, which restores full funding to the Congressionally Directed Medical Research Programs (CDMRP). The bill is endorsed by 71 organizations and includes 22 original cosponsors.

In March, House Republicans passed the Full-Year Continuing Appropriations and Extensions Act of 2025 that cut the CDMRP by 57%, putting thousands of medical breakthroughs at risk.

The CDMRP was established in Congress in 1993 and plays a vital role in advancing groundbreaking, peer-reviewed medical research. Administered by the Department of Defense, these programs are often the only source of federal funding for innovative, high-risk, high-reward research, particularly for conditions that disproportionately affect our veterans, service members, and underrepresented communities. That includes pancreatic cancer, breast cancer, ALS, multiple sclerosis, and many others.

In Indiana, the CDMRP has funded research at the <u>Indiana University School of Medicine</u> to improve treatment for mild traumatic brain injuries, as well as a <u>collaboration between the IU School of Medicine and Purdue University</u> to develop a device for spinal cord injuries. Nationwide, the CDMRP has contributed to lifesaving research addressing breast cancer, chronic pain management, epilepsy, melanoma, multiple sclerosis, and more.

"This program must be immediately restored to its full strength to save lives, save jobs, and to serve our brave servicemembers and veterans," **said Congressman Carson.** "Interrupting this research means we not only lose out on our investment, but we lose out on lifesaving solutions to some of the most devastating health issues our country faces. At this very moment, veterans, children, and families are desperately waiting for medical breakthroughs. We can't afford to make them wait any longer."

"Earlier this year, House Republicans cut funding for medical research on diseases that disproportionately affect veterans and service members. This endangers the lives of our nation's heroes and makes us all less safe," **said Rep. Mike Levin (CA-49).** "This bill ensures that lifesaving research on military-relevant medical conditions are once again fully funded. I'm proud to partner with Rep. Carson on this bill to ensure we never shortchange the health of our veterans and service members."

"The Medical Research for Our Troops Act will restore vital research funding that earlier this year was mistakenly cut by 57% by the Continuing Resolution," **stated**Mark Vieth, Coordinator of the Defense Health Research Consortium (DHRC). "The DHRC applauds Representatives Carson and Levin for their leadership on this issue and their dedication to medical research into the health challenges faced by members of the Armed Services. This legislation is essential not only for advancing treatments and cures for cancers and other conditions, but also for stemming the brain drain of our nation's medical research talent to China and Europe."
